IMPORTANT - READ CAREFULLY.

PARTICIPANT AGREEMENT

(Including Acknowledgement and Assumption of Risks, Agreements of Release and Indemnity)

In consideration of being allowed to participate in water sport events and activities and/or being provided with water sport recreational property of services, for myself and any minor children for whom I am a parent, legal guardian or otherwise responsible, and for my/our heirs, personal representatives or assigns:

Acknowledgement of Risks: I understand that participation in these activities involves risk of serious injury, including but not limited to, bodily, mental injury, disability, paralysis, pain, suffering, or death. Dangers may include tipping or turning over of watercraft; entanglement in trees or other obstructions; exposure to heat, cold, lightning, strong currents, injurious plants, insects, animals or other elements; sunburn, dehydration; heat stroke; muscle cramps; exhaustion; hypothermia; or accidental drowning. I understand that risks and dangers may result from the acts or omissions of myself or third parties, or of Bastrop River Company, its agents, employees, owners, participants, or others acting on their behalf. With full knowledge of the risks and dangers, I represent that I am in good health and proper physical condition to participate in the activities of Bastrop River Company. I do not have health problems or medical conditions that preclude participation. Alcohol will, and other substances may, impair judgment and reduce a participant's ability to effectively manage the risks of water travel, camping and land activities. Participants should always wear a fastened personal flotation device. Participants should wear footwear which will provide protection from sharp objects, and which will minimize the risk of foot entrapment. Failure to follow these and other safety precautions may result in injury or death.

- Express Assumption of Risks:** I, the Participant (adult or minor) and the parent, guardian or otherwise responsible, of a minor Participant, agree to assume all responsibility for all the risks of the activity, whether identified above or not, (EVEN THOSE RISKS ARISING OUT OF THE NEGLIGENCE OF THE RELEASES NAMED BELOW). My/our participation in the activity is purely voluntary. I assume full responsibility for myself and minor children for whom I am responsible, for any bodily injury, accident, illness, paralysis, death, loss of personal property and expenses thereof as a result of any accident which may occur while I/we participate in the activity (EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE RELEASED NAMED BELOW).
- Agreements of Release and Indemnification:** I hereby release Provider, its employees, volunteers, directors and owners ("Released Parties") from any and all claims of injury or loss (including death) which I, or the minor child for whom I sign, may suffer, arising out of or in any way related to my, or the child's, enrollment in or participation in the activities of Provider other use of its equipment, even if caused by the negligence of any of the releases named above, or any other person (including myself).

I will indemnify each Released Party from any claim liability, including one brought by or for a minor child for whom I sign, a co-participant in any of the activities of Provider, a rescuer, a member of my, or the minor child's, family, or anyone else, asserting a loss arising out of or in any way related to my, or my child's, enrollment in or participation in the activities of Provider or the use of its equipment.
