

AGREEMENT TO WAIVE LIABILITY, TO ASSUME RISK, TO INDEMNIFY AND IMAGE RELEASE

I, _____ in consideration of being permitted to participate myself and/or as the legal guardian for the under aged participant _____ in the Activities (as defined below) conducted by Cloud 9 Flight Adventures and Matthew T. Anderson, an FAA Certified Flight Instructor and Licensed Sport Pilot, (hereinafter referred to as CFI) I agree as follows:

_____ **Activities** - I would like to participate and/or grant full permission for an under aged participant in various activities including but not limited to the following activities: Riding as a passenger onboard a Special Light Sport Aircraft, (SLSA), moving about the exterior of the aircraft while on the ground, boarding and un-boarding the aircraft, and all related activities.

_____ **Assumption of Risk** - I understand that flying in private aircraft, including experimental and Special Light Sport Aircraft necessarily entails the risk of bodily injury, death and property damage from pilot error or other operational errors. In addition, flights could result in injuries from a combination of factors including but not limited to: engine or mechanical failure, latent defects in the aircraft, negligent maintenance, defects in runways, interference by wildlife or foreign objects, difficult search and rescue, unfavorable weather or terrain, the possibility of contaminated fuel, hard or forced landing, turbulence, or other causes. Injuries that could result will vary, but may include (a) minor injuries such as scratches, bruises and sprains, (b) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks and concussions, and (c) catastrophic injuries, including paralysis and even death. Notwithstanding these risks and other hazards that may be foreseeable but not specifically identified herein, I, for myself, my heirs, personal representatives and assigns, understand, acknowledge, and expressly and voluntarily assume all risks and full responsibility for any injury, death or property damages arising out of or related to the Activities

_____ **Personal Items** – I agree that all personal items that I carry on board the aircraft will be properly stowed, or tethered to a lanyard (e.g. phones/cameras). I assume all risk of loss regarding personal items that may get lost or damaged. I understand that if a personal item should fall out of the aircraft, that we will likely be forced to make an emergency landing due to likely damage to the propeller.

_____ **Release, Discharge, and Agreement Not to Sue** - I, for myself, my heirs, personal representatives and assigns, do hereby release, discharge and agree not to sue CFI, his heirs, estate and family from any and all claims that we might otherwise have against CFI, for any injury or death to the participant, or for any damage to our property, arising from, but not limited to, participation in the Activities. This release, discharge and covenant not to sue shall relate to any and all claims or legal rights now existing or arising in the future, including claims and legal rights arising out of any active or passive negligence of CFI, and any other breach of a legal duty arising by common law, statute, contract or otherwise.

_____ **Indemnification and Hold Harmless** - I agree to indemnify and hold CFI, his heirs, family and estate harmless from, without limitation, any and all claims, actions, suits, procedures, costs, expenses, damages, and liabilities, including attorney's fees, incurred, brought as a result of or arising out of my involvement in the Activities and to reimburse CFI for any such costs and expenses as they are incurred. I expressly acknowledge and agree that this duty to indemnify and hold CFI harmless shall apply even under circumstances where CFI has acted in a negligent or tortious manner.

_____ **Acknowledgements and Full Release** - I acknowledge that CFI has given me the opportunity to discuss the provisions of this document with legal counsel, and that I have either had such discussions, or chosen not to do so. I also acknowledge that I have been given the right to object to and bargain regarding any of these provisions, but have voluntarily and knowingly chosen not to do so. I am freely and voluntarily signing this Agreement and intend that my signature be the complete and unconditional release of all liability to the greatest extent allowed by law.

_____ **Severability** - I expressly agree that these agreements are intended to be as broad and inclusive as is permitted by the law of the State in which the Activities are to be conducted and that if any part of any provision is held to be invalid, it is agreed that the balance of the provisions shall continue in full legal force and effect, notwithstanding such invalidity.

_____ **Image Release** - I release CFI from any compensation and hereby agree to allow CFI to use my Image for any marketing on any social media sites, websites, printed material and other promotional activities.

BEFORE SIGNING, READ THIS ENTIRE DOCUMENT VERY CAREFULLY. If an accident were to occur, you (by signing this Agreement) would be giving up legal rights that you might otherwise have.
