This Agreement & Release ("Agreement") covers the use of a Stand-Up Paddle Board ("SUP") & related equipment which is being provided by Triad ECO Adventures for an on-water lesson, tour, or event....

1. **USE & OPERATION.** Triad ECO Adventures staff will provide basic instruction on the SUP; as I agree to use and operate the SUP in the careful, considerate and safe manner as instructed, with due consideration for the safety and well being of all persons and property. I understand that a life vest is provided for my safety and I agree to wear the life vest at all times when aboard the SUP. I understand and agree to cease operation of the SUP if I am concerned in *any* way about the operation or damage to the SUP. I also certify that I can SWIM!

2. **RIDER WEIGHT.** I certify that I weigh between 75 and 290 pounds, which is in compliance with normal SUP weight guidelines.

3. **ASSUMPTION OF RISK.** I understand and acknowledge that use of an SUP has a potential for injury or death to persons, including the operator, and for loss damage to property (including the SUP) and I assume the risk of such injury, loss or damage.

4. **RELEASE WAIVER OF LIABILITY INDEMNITY AGREEMENT.** I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE TRIAD ECO ADVENTURES, ITS OWNERS AND EMPLOYEES, FROM ALL LIABILITY on account of injury to me whether caused by the negligence or gross negligence of Triad ECO Adventurers. I HEREBY AGREE TO INDEMNIFY,SAVE HOLD HARMLESS AND DEFEND TRIAD ECO ADVENTURES, IT'S OWNERS AND EMPLOYEES, from any and all claims related to my use of the SUP. I HEREBY ASSUME FULL RESPONSIBILITY FOR RISK OF BODLY INJURY DUE TO THE NEGLIGENCE OR GROSS NEGLIGENCE OF THRIAD ECO ADVENTURES OR OTHERWISE while participating in the use of the SUP. I expressly acknowledge and agree that the activities of the SUP involve risk of injury.I further expressly agree that the foregoing release; waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by law of North Carolina. I HAVE READ AND VOLUNTARILY SIGNED THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT and further agree that no oral representation, statement or inducements apart from the foregoing written agreement have been made.

5. **GOVERNING LAW** This Agreement shall be governed by and constructed under the laws of the State of North Carolina.

6. **MODEL RELEASE.** I understand that Triad ECO Adventures routinely takes photographs during its lessons/tours which show the participants experiencing the lessons/tours. I give Triad ECO Adventures my permission to publish said photos, which may contain my likeness, on its website, in ads, store displays & promotional materials, both online and in print, for the purpose of promoting SUP tours.

For safety reasons... pregnant women & anyone weighing over 290 pounds may NOT participate in the lesson / tour.

PLEASE BE ADVISED THAT YOU ARE FINANCIALLY RESPONSIBLE FOR ANY SIGNIFICANT SUP DAMAGE THAT MAY OCCUR DURING YOUR LESSON/TOUR. I have read and understand the meaning and effect of this Triad ECO Adventures Release Agreement and I accept the use of the SUP under these terms and conditions. I certify that I am at least 12 years old.

I HAVE READ & UNDERSTAND THIS RELEASE AGREEMENT (If rider is younger than 18 years old an *adult* signature is required!).
