I further acknowledge and waive legal rights that may occur as the result of my participation in any activity involving the use of horses, including, but not limited to being on, around, about, under, riding or falling off of horses of any size; both on and off the property owned by the Williams family, and do hereby hold harmless and agree to indemnify the Reindeer Farm and Reindeer Tours and each and every member of the Williams family and their employees from any liability which may occur in any way as a result of this activity.

It has been explained to me and understood by me that horses, while generally considered gentle, have certain individual traits which can cause them to be dangerous in a way that may injure me. Horses may react in an unforeseen and unpredictable manner, placing those about them in risk and danger. I do hereby acknowledge those risks, and voluntarily assume the risks as my own.

RULES OF CONDUCT

1. No litter will be left anywhere at any time.
2. Horses will never be galloped, except in the presence of and by permission of an employee of, or member of the Williams family.
3. Follow instructions of the guide at all times, or you may be asked to dismount.
4. Frowning will not be tolerated; guests and visitors must, at all times, be happy and smiling!

Visitor's Acknowledgement of Risk and Release

In consideration of the use of a horse, equipment and services of Reindeer Farm, Reindeer Tours their officers, agents, employees, directors, and stockholders, and all other persons or entities associated with the same (hereinafter collectively referred to as "Stable", for the purpose of riding with Reindeer Farm, Reindeer Tours at any location , I agree as follows,

I acknowledge the use, handling, and riding of a horse involves a risk or physical injury to any individual undertaking such activities. Horse reactions to strange sounds, sudden movement and unfamiliar objects persons and other animals are unpredictable regardless of a horses training and usual past behavior. When frightened or provoked, regardless of the reason, the horse may stop short, change direction or speed at will, shift its' weight, buck, rear, bite, or run from danger. I understand that there may be other unknown or unanticipated risks that set forth herein. I agree to assume responsibility for the risk of the use, handling and riding of a horse.

I understand that upon mounting a horse and taking up the reins the rider is in primary control of the horse. The rider's safety largely depends upon his/her ability to carry out simple instructions, and his/her ability to remain balanced aboard the moving animal. I agree that the rider shall be responsible for his/her own safety and that of her unborn child if the rider is pregnant. The STABLE advises pregnant women not to ride horse, unless permission has been given under advice of her doctor.

Reindeer Farm/Reindeer Tours has the right to the use of any photos taken for publicity, ads, or brochures.

I waive all claims, suits, action, damages and cost including reasonable attorney's fees and court cost against Reindeer Farm, Reindeer Tours and Williams Farm, and release them from any and all liability, including, but not limited to The Stable's own negligence for damage to property or injury or death to any person or persons, in any way arising out of or connected with or resulting from the use, handling or riding of a horse or otherwise related to horse activities. I agree that any dispute arising out of this Agreement shall be submitted to binding arbitration in Palmer, AK. I also consent to any emergency first-aid or medical treatment for injuries to me.

WARNING

Under Alaska Law, an Equine professional is not liable for an injury to or death of a participant in Equine activities resulting from the inherent risk of Equine activities.

I have read, understood, and accepted the terms and conditions stated herein and acknowledge that this Agreement shall be effective and binding upon myself, my successors or assigns. If I allow a minor to participate in this activity, I not only assume the risk, but agree to indemnify The Stables for any liability, including but not limited to costs and attorney's fees, that they may incur as a result of the minor's participation in this activity.
