V. <u>JET SKI SAFETY RULES</u>

Renter shall familiarize himself/herself with all operating instructions for the PWC. Renter shall assure that the personal watercraft is used in a safe manner utilizing the highest standard of care to avoid injuries and damage to the PWC or other property. The PWC shall not be used in connection with stunts, racing, the towing of person or property, or any other use which might result in injury to person or damage to property. - 1. I will not allow any other person to operate the watercraft.

- 3. I will always wear a life jacket.
- 4. I will not permit anyone under the age of 18 on watercraft without signing all forms.
- 5. I will only allow persons who have signed the rental agreement and PWC Checklist to operate the PWC.
- 6. I will follow all boating safety rules.

VI. GENERAL TERMS AND CONDITIONS

This Rental Agreement sets forth the entire agreement and understanding between the parties, and all previous discussions, understanding, representations, negotiations, and agreements with respect to the matters included in this Rental Agreement are merged herein. Additionally, the consideration recited herein is the full, complete and entire consideration for this Rental Agreement, and there is no further consideration to be paid by any party to any other party other than as recited herein.

If any provision or part of provision of the Rental Agreement shall be determined to be void or unenforceable by a court of competent jurisdiction, the remainder of the Rental Agreement shall remain valid and enforceable by any party.

This Rental Agreement shall be governed by and construed under the laws of the State of South Carolina. In the event <u>Rental company</u> prevails in any litigation or claim relating to the enforcement of the provisions contained herein, I agree to pay and indemnify <u>Rental company</u> for its litigation expenses, including reasonable legal fees and court costs.

I understand that I am liable for all damages and costs incurred as a result of my negligence including but not limited to damages and lost rentals due to damage to any vessel. I agree to IMMEDIATELY REIMBURSE Rental company for these repairs and other costs. Most repair costs are calculated according to the repair table attached to this contract. Any damage that is not priced on the repair table is billed at actual cost to Rental company plus actual installation/repair costs billed to Rental company by repair facility.

I expressly warrant and represent that before executing this Rental Agreement I have fully informed myself of the terms, conditions and effects of this Rental Agreement, and that I have relied solely on my own judgment in executing this document.

I have read the terms of this Rental Agreement, including the provisions regarding Assumption of Risk, Release and Covenant Not to Sue, and Indemnity, and I understand that I am giving up substantial rights in consideration for my use of Rental company's watercraft and equipment. I enter into this Rental Agreement freely and voluntarily without any inducement.
