

WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19 RELEASE FORM FOR KELOWNA WATER PARK LTD, PENTICTON WATER PARK LTD; OPERATING AS SPLASH BC WATER PARKS
