Member understands the risks associated with boat excursions and voluntarily agrees to assume full responsibility for personal injury to participant and/or participants family members or for any loss or damage to participant personal property and expenses thereof as a result of participants negligence or the negligence of the participants family participating in said excursions. Understands that **The Woodruff Group LLC, dba Woody's on the Lake** reserves the right to refuse any person it judges to be incapable of meeting the requirements of participating in the Boat Club.

___ It is agreed that it is the participants responsibility to keep the Boat and Equipment in the same condition as it was received and be responsible for damages. Member agrees to reimburse **The Woodruff Group LLC, dba Woody's on the Lake** for any damages caused by member. Member is responsible for any and all damages and the credit card on file will be charged for said damages.

I on behalf of myself, my personal representatives and my heirs hereby understand that I am releasing discharging and waiving any claims or action that my have presently or in the future for the negligent acts or other conduct of myself, the owner, agent, officers, or employees of **The Woodruff Group LLC, dba Woody's on the Lake**.

___ Member agrees to this acknowledgement on behalf of minors. Member agrees to be personally responsible for the minor(s), and for the minor to follow and abide by all rules and acknowledge that participant is responsible for any damages caused by boat or property of **The Woodruff Group LLC, dba Woody's on the Lake**. **Member agrees all minors under 13 will wear a life jacket at all times while on the boat and it is the responsibility of parent or guardian to ensure the minors wears life jacket at all times and follows safety precautions while on and off the boat.**

___ Member acknowledges failure to comply will result in termination of membership. No refunds will be given for termination and member will be responsible for the monthly payments until the yearly contract ends.
