Regulation: For everything to turn out well and you enjoy it to the fullest, it is necessary that you comply with the following:

- Respect the departure time and food so as not to alter the program.
- Respect the indications and customs of the places we visit.
- Respect the route guide, do not get ahead of yourself, they are routes do not race.
- Any reckless or unsportsmanlike conduct will be grounds for being expelled from the route.
- All participants must always wear their safety equipment.
- In descents keep a prudent distance with respect to the next partner to avoid accidents and injuries.
- You must carry a moderate speed to carry a compact group and not delay it,
- Collect your garbage, you must keep it until you find the best place to deposit it, the guides are not responsible for your garbage *Leave the places better than you find them.*
- Failure to comply with the rules established by Alternative Tourism En Guanajuato can be cause
 for a call for attention and / or expulsion from the route, the important thing is the safety and wellbeing of all. Help us make this route a SUCCESS.
- TO MENTION A FEW, if you need to consult it, request it and / or look for it on the website.

Responsibility. Alternative Tourism En Guanajuato provides you on your route and / or route an accident insurance for the participant obtained by registering with the association Tourism of Nature and Adventure of Guanajuato AC. Through policy AG-26913-00 issued by THONA Seguros S.A. de C.V., which marks a deductible of \$ 1,000.00 which must be paid by the participant, additionally there is a Civil Liability insurance for the participant and the company Through the SEMP-3704-15 policy issued by Seguros El Potosí S.A. de C.V., which marks a deductible of 2.5% on loss of at least 25 UMAS which must be paid by the participant. each one participates at his own risk knowing the degree of physical effort involved in these adventure activities and declares to be physically healthy and fit for sports and adventure activities or outdoor ecotourism, The expenses generated by cures and / or hospitalization less than the deductible will also be covered by the signatory of this registry.

In the case of the **Globo**, they are adapted to the insurance policy required of the pilot by the SCT and civil aeronautics.

<u>Voluntary Resignation.</u> To the Ingestion of Alcoholic Beverages Before and During the Route and to the handling of a high-sounding language, we reserve the right to expel from the route the person who violates this rule, exempting from all responsibility Alternative **Tourism En Guanajuato** and / or sponsors.

<u>Facilities and Food.</u> We look for the best ones for your stay on the routes and / or activities, sometimes we will visit typical places where the services are simple, this while remaining clean and quality, is part of the adventure.

<u>Safety and hygiene protocol.</u> Adhered to the global situation of the coronavirus, we develop this process in which at least the mandatory use of face masks is mentioned, maintaining a healthy distance of 1.5 meters and the correct disinfection of the material or equipment to be used in any in the activities of **Alternative Tourism En Guanajuato**. which is complete and detailed on our website.

<u>Other.</u> The route is subject to changes or cancellations due to natural and atmospheric phenomena (extreme cold, storm, rain)

Sometimes the activity will take place in protected natural areas and we must abide by the rules of the place.

For the agility of the group, instructions will be given by the guides to be able to stop to take photographs and / or video.

There is a first aid kit and its training by the guides for its correct use, as well as constant communication.

By virtue of this manifest that it is my free will to participate in the route and / or activity and that I know the risks involved in participating in Alternative Tourism En Guanajuato consequently in this act <u>I release and demarcate</u> Alternative Tourism En Guanajuato and / or its sponsors as well as all the companies participating in the organization of the route, of any civil, legal or criminal liability that may result from my participation in this route.

The company is responsible for any accident that happens in the development of recreational activity, if it is irresponsibility or negligence of the guide, as well as for the use of inadequate equipment.
