Wavier and Release of Liability, Assumption of Risk, and Indemnity Agreement

Warning: Read carefully, this agreement includes a release of liability and wavier of legal rights and deprives you the right to sue Bandit Axe House, LLC, and other parties. Do not sign this agreement unless you have read it in its entirety. Seek the advice of legal counsel if you are unsure of its effect.

In consideration of Bandit Axe House, LLC (“Bandit Axe House”) allowing me to participate in any and all recreational activities or events in which Bandit Axe House is in any way involved the (“Activities”), I, for myself, and on behalf of my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors and assigns, hereby agree to and make the following contractual representatives pursuant to this Wavier and Release of Liability, Assumption of Risk, and Indemnity Agreement the (“Agreement”): (the “Risks”), Agreement and shall not affect the validity and enforceability of any remaining provisions.

YOU AGREE TO THE FOLLOWING:

- 1) I hereby represent that (I) I am in good enough health and in proper physical condition to participate in the Activities; and (II) I am not under the influence of alcohol or any illicit or prescription drugs which would in any way impair my ability to safely participate in the Activities. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Activities.

- 2) I understand and acknowledge the physical and mental rigors associated with the Activities and inherently dangerous and represent an extreme test of a person’s physical and mental limits and conditions. I understand that participation in the Activities involves risks and dangers which include, without limitation: the potential for serious bodily injury, sickness and disease, permanent disability, paralysis, and loss of life; loss of or damage to equipment/property; exposure to extreme conditions and circumstances; accidents, contacts or collisions with other participants, spectators, vehicles, or natural manmade objects; dangers arising from adverse weather conditions; imperfect conditions existing on the property where the Activities take place; equipment failure; inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the organizers of the Activities; and other undefined risks and dangers which may not be readily foreseeable or are presently unknown (“Risks”). I understand that these Risks may be caused in whole or in part by my own actions or inactions, the actions or inactions others participating in the

Activities, or the acts, inactions, or negligence of the Released Parties, I hereby expressly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses which I incur as a result of my participation in the Activities.

- 3) I agree to be familiar with and to abide by all rules and regulations established for the Activities in which I participate. I also accept sole responsibility for my own conduct and actions while participating in these Activities and the condition and adequacy of any equipment that I might own and supply in conjunction with those Activities.

- 4) I hereby release, waive, and covenant not to sue, and further agree to indemnify, defend, and hold harmless the Related Parties, together with the organizers, promoters, sponsors, advertisers, hosts, venue and property owners upon which the Activities take place, and each of their respective parent, subsidiary and affiliated companies, officers, directors, partners, shareholders, members, agents, employees, and volunteers with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss of expense, including court costs and reasonable attorney's fees of any kind of nature ("Liability") which may arise out of, result from, or relate to my participation in the Activities, including claims for Liability caused in whole or in part by the negligence of the Released Parties, I will indemnify, defend, and hold harmless each of the Released Parties from any such Liability which may be incurred as a result of such claim. I hereby warrant that I have read the Agreement carefully, understand its terms and conditions, acknowledge that I will be giving up substantial legal rights by signing it ***(including the rights of the minors, my spouse, children, parents, guardians, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns)***, and acknowledge that I have signed this Agreement freely and voluntarily, without any inducement, assurance or guarantee, and confirmation of my complete understanding between the parties regarding these issues and no oral representation, statements, or inducements have been made apart from this Agreement.
