



Participation Agreement

MINOR / YOUTH PARTICIPANT

PARTICIPANT AGREEMENT:(Including Acknowledgement and Assumption of Risks, Agreements of Release and Indemnity)

In consideration of being allowed to participate in water sport events and activities and/or being provided with water sport recreational property or services, **for a minor child** for whom I am a parent, legal guardian or otherwise responsible.

ACKNOWLEDGMENT OF RISKS: I understand that participation in these activities involves risk of injury, including but not limited to, bodily, mental, disability, paralysis, pain, suffering, or death. Dangers may include tipping or turning over of watercraft; entanglement in trees or other obstructions; exposure to heat, cold, lightning, strong currents, injurious plants, insects, animals or other elements; sunburn, dehydration; heat stroke; muscle cramps; exhaustion; hypothermia; or accidental drowning. I understand that risks and dangers may result from the acts or omissions of the minor participant or third parties, or of Bastrop River Co, its agents, employees, owners, participants, or others acting on their behalf. With full acknowledgment of the risks and dangers, **I represent that participant is in good health and proper physical condition to participate in the activities of Bastrop River Co. and does not have health problems or medical conditions that preclude participation.**

Participants should always wear a fastened personal flotation device. Participants should wear footwear which will provide protection from sharp objects.. Failure to follow these and other safety precautions may result in injury or death.

1. **Express Assumption of Risks:** Participation in the activity is purely voluntary. I, the parent, guardian or otherwise responsible, of a minor participant, agree to assume all responsibility for all the risks of the activity, whether identified above or not, **(EVEN THOSE RISKS ARISING OUT OF THE NEGLIGENCE OF THE RELEASED PARTY).**

2. **Agreements of Release and Indemnification:** I hereby release Bastrop River Co, its employees, volunteers, directors and owners ("Released Parties") from any and all claims of injury or loss (including death) which I, or the minor child for whom I sign, may suffer arising out of or in any way related to the child's enrollment in or participation in the activities of Bastrop River Co or use of its equipment, even if caused by the negligence of the Released Parties, or any other person (including myself).

I will indemnify each Released Party from any claim liability, including one brought by or for the minor child for whom I sign, a co-participant in any of the activities, a rescuer, a member of my, or the minor child's family, or anyone else asserting a loss arising out of or in any way related to the child's enrollment in or participation in the activities of Bastrop River Co or the use of its equipment.

MEDIA AGREEMENT: I hereby grant to Bastrop River Co the right to use, publish and reproduce for promotional purposes images (pictures & video) taken by Bastrop River Co in which participant appears, and waive the right to receive any payment or approve finished material for use of said images and/or audio.
