

# **SECURITY GUARD JOB DESCRIPTION**

Job Title: Security Guard FLSA Status: Non-Exempt Department: Facilities/Security Reports to: General Curator

**Job Summary:** The Security Guard will protect people, animals, and property from possible criminal or other potentially harmful activity.

Duties and Responsibilities: (Including but not limited to)

- 1. Secures personnel, animals, and property by patrolling property, monitoring surveillance equipment, and checking all access points.
- 2. Patrols and monitor specific areas within the property including the parking lot as assigned by management.
- 3. Investigates security breaches, incidents, and other alarming behavior.
- 4. Investigates reports by others of suspicious activity on the property.
- 5. Reports suspicious activities to the General Curator and/or local authorities.
- 6. Contacts law enforcement or fire department in case of an emergency.
- 7. After business hours, checks doors, windows, and gates to ensure the property is secure.
- 8. Reasonably detains persons suspected of criminal activity until law enforcement arrives.
- 9. Escorts discharged staff, trespassers, and other unwelcome parties off the premises.
- 10. Complies with all Coral World V.I., Inc policies, procedures, and programs.
- 11. Performs other related duties as assigned.

#### **Supervisory Responsibilities:**

This position has no supervisory responsibilities.

#### **Work Environment:**

This job operates in an outdoor environment where the employee will be exposed to sunny, warm, humid and wet conditions.

### **Position Type and Expected Hours of Work**

This can be a full or part time position. Days are scheduled around a 7 day work week. Hours include evening and overnight hours.

- Knowledge of security protocol and procedures.
- Excellent written and verbal communication skills.
- Excellent observational skills and attention to detail.

- Ability to learn the layout of the property and buildings.

#### **Education and Experience**

- High school diploma or equivalent required
- Previous experience as a security guard
- Security guard training certification preferred.

- Ability to traverse various areas of the facility to conduct inspections and plan security procedures.
- Ability to patrol the property and access areas quickly.
